Federal Customs Administration



Among other things, Germany's Federal Customs Administration is responsible for checking goods crossing the country's borders (land borders with other countries, airports and sea ports) as well as for establishing and collecting import duties (customs, import sales tax and excise taxes).

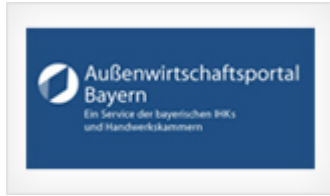
Bayern International

Federal Statistical Office

Germany's Federal Statistics Office supplies, among other



things, data on Germany's foreign trade, publications on international reference figures, annals on international statistics and the "Country Profiles" series.

Eurostat

Renewable Energies Export Initiative



The Renewable Energies Export Initiative supports German companies by supplying information, by networking existing initiatives and activities as well as by actively assisting companies in international projects for exporting renewable energy technologies.

Energy Efficiency Export Initiative



The Energy Efficiency Export Initiative supports companies with individually tailored business trips for establishing business contacts with potential partner companies abroad.

Enterprise Europe Network
